We thank you for your interest in SWADE, the Scranton-Wilkes-Barre Auto Dealers Exchange Inc. We value our relationship with our dealers, and fully respect their rights.

This Privacy Policy explains how SWADE collects and uses and information about you and your dealership online and via forms both electronic and printed. We respect your personal privacy and we are committed to protecting it.

Your IP address

Servers automatically collect information about which pages are visited and the IP address or domain name of visitors. We use your IP address to help correct problems with our server, and to administer our web site. Information we collect
